

## Overview

---

Are crystalline silicon photovoltaic cells antidumping or countervailing duty?

The American Alliance for Solar Manufacturing Trade Committee filed both antidumping duty petitions and countervailing duty petitions on crystalline silicon photovoltaic cells, whether or not assembled into modules, from Cambodia, Malaysia, Thailand and Vietnam.

Can I import solar cells from Cambodia?

Imports of solar cells and modules from Cambodia, Malaysia, Thailand, and Vietnam will not be subject to suspension of liquidation or cash deposit requirements if accompanied by a certification attesting that they are not circumventing the ADD/CVD orders. There are three types of certifications:.

Does Cambodia export solar panels?

In 2022, Cambodia's solar panel exports soared by 2.8 times year-on-year to USD1.0 billion; the share of solar panel exports to the country's total exports rose to 4.6 percent from 1.4 percent.

What is the Commission's report on crystalline silicon photovoltaic cells?

The Commission's public report on Crystalline Silicon Photovoltaic Cells, Whether or Not Assembled into Modules, from Cambodia, Malaysia, Thailand, and Vietnam (Inv. Nos. 701-TA-722-725 and 731-TA-1690-1693 (Final), USITC Publication 5631, June 2025) will contain the views of the Commission and information developed during the investigations.

Why should Cambodia invest in solar panels?

Despite facing significant challenges, Cambodia possesses several advantages that would support the continued development of its solar panel industry. Cambodia can diversify its export destinations from the U.S. to developing economies, such as those in the Middle East or Africa who are transiting to greater use of renewable energy.



Which crystalline silicon photovoltaic cells are excluded from the study?

Also excluded from the scope of the investigations are crystalline silicon photovoltaic cells, not exceeding 10,000 mm<sup>2</sup> in surface area, that are permanently integrated into a consumer good whose function is other than power generation and that consumes the electricity generated by the integrated crystalline silicon photovoltaic cell.
