Czech energy storage project subsidies





Overview

The European Commission (EC) has authorized a €279 million (\$303 million) Czech state aid scheme to support investment into electricity storage facilities and foster the transition towards a net-zero economy. Does the Czech government provide subsidies for electricity storage?

However, the Czech government provides subsidies to household projects consisting of photovoltaic panels with electricity storage systems. Batteries and thermal energy storage are the two most commonly used methods of electricity storage for households in the Czech Republic. 2.

How does the Czech government subsidise photovoltaic panels?

The Czech government subsidises the installation of photovoltaic panels located on domestic properties producing energy for their own consumption and the purchase of co-located energy storage solutions. These subsidies are provided under the “New Green Savings Programme” administered by the State Environmental Fund.

Is there a future for energy storage in the Czech Republic?

Despite the ongoing discussions, there is no significant development in the area of energy storage. In 2015, the Czech Government adopted the National Action Plan for Smart Grids (“NAPSG”) prepared by the Ministry of Industry and Trade under principles set out in the update of the State Energy Concept, which was also introduced in 2015.

What subsidies does the Czech Republic provide for the use of coal?

The Czech Republic provides subsidies related to the use of coal. Among those are subsidies for the retrofitting of existing coal-fired power (though those are no longer available) and co-generation plants to make them more efficient and extend their life cycle. However, funding for retrofitting that substitutes coal with coal is not permitted.

Are pumped hydro storage projects eligible for state subsidies?



Pumped hydro storage projects are not eligible for any state subsidies. The Czech government subsidises the installation of photovoltaic panels located on domestic properties producing energy for their own consumption and the purchase of co-located energy storage solutions.
