# **Energy Storage Power Station Settlement**





## Overview

---

Kentucky's attorney general and largest electric utility provider agreed to a proposed settlement this week in a case before state regulators, which would scrap plans for a battery storage facility and instead extend the life of its coal-fired power plant in Louisville. Why did Vistra Energy shut down?

That closure came about as the result of a 2019 federal consent decree settling a Clean Air Act lawsuit that environmental groups first filed against the facility in 2013. Plant owner Vistra Energy plans to convert the power plant site for 37 megawatts of battery energy storage. That's enough to power more than 18,000 homes.

How much energy storage is being added in 2025?

Accelerating development of electricity storage, targeting additions totaling 230 MW in 2025, 120 MW in 2027, and 430 MW in 2028 with approximately 35% being owned by third parties. The company aims to add more than 1,800 MW of energy storage by 2042. Increase its energy waste reduction target to 2% savings in 2023-27.

How much money does DTE Energy Co donate a year?

Donate \$38 million to organizations that provide utility bill assistance and home energy efficiency improvements for income-eligible households. Disclose annually all political donations of \$5,000 or more made by DTE Energy Co. beginning in 2024.

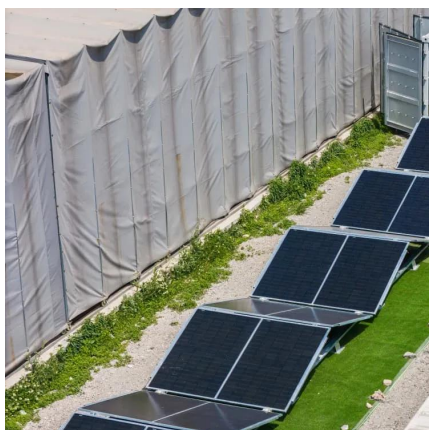

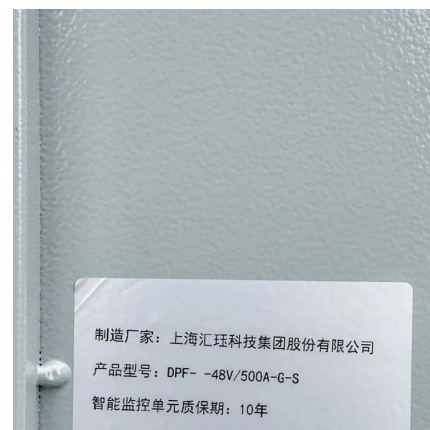

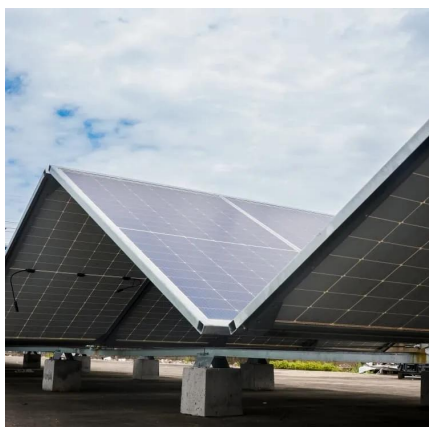
