Greece's energy regulator has announced three separate auctions for standalone energy storage systems connected to electricity transmission networks. What is Greece's third energy storage auction?

Greece's third energy storage auction has been completed with nine projects selected. It was the final auction where the state provides subsidies to build battery energy storage systems (BESS). A total of almost 800 MW in capability has been awarded through all three storage auctions.

Is Greece preparing for a new energy storage auction?

Greece is gearing up for its second competitive auction for standalone, frontof-the-meter energy storage facilities connected to the electricity transmission network. The auction is part of Greece's 1 GW energy storage program.

Does Greece have a 1 GW energy storage program?

The auction is part of Greece's 1 GW energy storage program. The country announced its 1 GW energy storage program in the summer with three separate tenders featuring 400 MW, 300 MW and 300 MW of capacity. The first tender awarded 12 energy storage projects in August, with 411,79 MW of capacity in total.

Which energy storage projects will be included in Greece's energy tenders?

The program's first and second tenders will focus on standalone energy storage projects connected to the Greek electricity transmission network. The



tenders exclude the island network of Crete, which was linked to Greece's mainland power grid in 2021.

What is Greece's energy storage program?

Greece's energy storage program will draw €341 million (\$372.3 million) from the European Union's post-pandemic recovery fund, which was approved last year by the European Commission. The program's first and second tenders will focus on standalone energy storage projects connected to the Greek electricity transmission network.


