

# Joint cooperation plan for manufacturing energy storage vehicles





#### **Overview**

How will JSW Energy & Iges work together?

It is intended for the joint venture to be a 50:50 partnership. JSW Energy contributes substantial capital investment, while LGES will supply the state-of-the-art machinery and technology. Together, they intend to build a battery production plant capable of producing 10 gigawatt hours (GWh).

What is a joint venture and how does it work?

Moreover, the joint venture aims at jointly building up precursor and cathode material production capacities in Europe, and sustainably securing responsibly sourced raw material capacities at competitive prices. Close cooperation to foster cost optimization activities and increase efficiencies in production



processes are also on the agenda.




