#### **Overview**

Does Italy have a photovoltaic subsidy policy?

In addition, Italy recently introduced a new subsidy policy, providing 90% of the installed cost subsidy for the newly installed photovoltaic capacity for agricultural purposes, in order to support agricultural, aquaculture, and agroindustrial companies to invest in expanding photovoltaic power generation.

How much is a subsidy if you work in Monaco?

The subsidy is set at 35% of the cost of the work, with a limit of 50,000 euros. Again, bonuses are available if you use a Monaco-based company. 4. Let the sunshine in!.

How much does a photovoltaic system cost?

Subsidy costs: PV category A: €285/kWp (max.) PV category B: €250/kWp (max.) Photovoltaic category C: €180/kWp (max.) Photovoltaic category D: €170/kWp (max.) Electricity storage: €200/kWp (only subsidised for storage equipment combined with new or extended photovoltaic systems).

Do you get a bonus if you use a Monaco based company?

Bonuses are provided if you use a Monaco-based company to carry out the work. It is therefore easier to replace your single-glazed windows to keep out the cold and considerably reduce your energy and financial consumption!
