

# Photovoltaic panel antidumping device and price







#### **Overview**

What are the anti-dumping and countervailing duties on solar panels?

The countervailing and anti-dumping duties are in response to a petition that a group of seven solar panel manufacturers called the American Alliance for Solar Manufacturing Trade Committee filed with the US government in April 2024.

Are crystalline solar cells affected by US anti-dumping duties?

The US Commerce Department set final countervailing and anti-dumping duty rates on Monday for crystalline solar cells and modules imported from four southeast Asian countries. Cells and modules from Vietnam, Malaysia, Thailand and Cambodia are affected. Importers have already been posting cash deposits for the duties since last fall.

Do 'anti-circumvention' tariffs on solar panels have to be paid?

They do not have to be paid on cells and modules that are already subject to separate "anti-circumvention" duties on equipment that Commerce found in an earlier Auxin investigation is being manufactured in southeast Asia using Chinese parts to avoid high tariffs on solar equipment manufactured wholly in China.

Will China still control 80% of solar module manufacturing?

However, that will not be an easy task when China still controls more than 80% of global solar manufacturing. Domestically, crystalline solar module manufacturing would increase, but at a higher cost, mainly due to higher cell



What is the rate of anti-dumping duty?

Please note that model information is posted only for exporters who have successfully enrolled in an exporter ID. For importations of subject goods for which the exporter has not been issued specific normal values, the rate of anti-dumping duty is equal to 154.4% of the export price.




